Weekly Market Recap

The stock market surged forward – fueled by a renewed rally in technology firms, propelling the S&P 500 beyond 5,100 and marking its 15th record high of the year. Closing out February with a remarkable 5% rally, the S&P 500 extended its winning streak for the fourth consecutive month. Meanwhile, the Nasdaq 100 saw a climb of almost 1.5% for the week, buoyed by a robust 4% surge in chipmakers, spearheaded by Nvidia Corp. Mega caps also saw gains, notably with Dell Technologies Inc., soaring by an impressive 32% on the strength of solid sales. Treasuries rose across the curve, with Two-Year Yields falling nine basis points to 4.53%. Market participants largely shrugged off lackluster economic data, betting on potential rate cuts as early as June. With the majority of S&P 500 companies reporting, fourth-quarter earnings have exceeded expectations, boasting nearly 8% growth compared to the anticipated 1.2% rise at the start of the season. These stellar performances helped counterbalance lingering macroeconomic uncertainties. The focus also turned to dissecting the latest commentary from a multitude of Federal Reserve speakers, seeking insights into the potential interest-rate trajectory. Over the past two months, traders have adjusted their expectations on when the Fed might begin rate cuts. The upcoming week promises a fresh batch of jobs data, offering market participants valuable insights as they anticipate the Fed's decisions at its upcoming meeting later this month.


