Weekly Market Recap

Stocks rose after data showed American consumers tempered their inflation expectations, bolstering sentiment regarding the prospects for Federal Reserve rate cuts this year. The S&P 500 rebounded after a two-day slide, reclaiming the 5,300 mark and erasing this week's losses in a session of low trading volume. The Nasdag 100 hit a fresh all-time high, led by gains in Nvidia Corp. and Apple Inc. Treasuries barely moved after Fed Governor Christopher Waller stated that he still believes the neutral interest rate is relatively low but warned that unsustainable fiscal spending could change that trend. The Fed's preferred inflation measure, the core PCE deflator, is due next Friday and is expected to show the slowest monthly increase this year. Swaps now fully price in the Fed's first full quarter-point rate cut for December, rather than November. Growth in activity at service providers was the fastest in a year, and manufacturing output expanded at a quicker pace. Such economic resilience is making it difficult for inflation to cool, which helps explain why the Fed is intent on keeping rates higher for longer. When traders return from the holiday weekend, the "T+1" rule will come into effect, reducing the settlement period for U.S. equities from two days to one.



Definitions and Disclosures

Market Recap and Chart of the Week: The Consumer Price Index measures the overall change in consumer prices based on a representative basket of good and services over time. Volcker era inflation refers to a period in time when Fed Chairman' Volcker dealt with inflation where at the end of his term, inflation was at a manageable rate at around four percent, while unemployment had fallen under six percent, as the economy grew and business confidence returned.

Abbreviations: MAX DD refers to Maximum Drawdown from 1/1/2000 to the as of data date indicated. A drawdown is a measure of peak to trough loss in a given period; maximum drawdown is a measure of the maximum peak to trough percentage loss in any given period. YTD refers to year to date and QTD refers to quarter to date.

Indices and Data: Equities: S&P 500 refers to the S&P 500 Index which is a stock market index based on the market capitalization of 500 leading companies publicly traded in the U.S. stock market, as determined by Standard & Poor's. Dow Jones Industrial Avg. (Average) is an index by Standard & Poor's that tracks 30 widely-traded blue chip stocks with large market capitalization. S&P 500 Buy Backs refers to the S&P 500 Buyback Index, which is designed to measure the performance of the top 100 stocks with the highest buyback ratios in the S&P 500. S&P 500 Low Volatility refers to the S&P 500 Low Volatility Index, which is designed to measure the performance of the 100 least volatile stocks in the S&P 500 Index. Equities Characteristics: Calculations and data for characteristics for indices are supplied by Bloomberg. Div. Yld refers to Dividend Yield and is the annual dividends per share divided by the price per share, expressed as a percentage. FCF Yld refers to Free Cash Flow Yield and is an overall return evaluation ratio of a stock, which standardizes the free cash flow per share a company is expected to earn against its market price per share: this ratio is calculated by taking the free cash flow per share divided by the share price.
